## 2019 Membership Renewal or Application Information and Instructions

*If you have not renewed in the last 2 years, you will need to complete orientation and join as a new member*

The basic Family membership fee includes up to three family members living at the same address and may include: i) a spouse, ii) dependent children age 18 or under, and/or iii) children age 25 or under who are full-time students. Additional family members may be added at a cost of \$20.00 each. The Senior Family membership rate is for two persons age 60 or over.

**RENEWING MEMBERS:** Former members who can prove their membership within the last 2 years may renew without orientation. The full annual rate applies regardless of the time of year renewed.

**Renewing in person:** Please *fully* fill out a membership application form each year. Bring your completed form together with your membership card and the cards of your family members to the PowderKeg where you can pay in cash, cheque or money order made payable to the KTSA. You will be issued year update stickers (or new card if you have lost the old one) and a new key to the range. Please ensure that each individual joining the club signs the application form.

**Renewing by mail:** Please mail your completed application form, payment and previous membership card(s) to KTSA, P.O. Box 744, Kamloops, BC V2C 5M4. (The KTSA is not responsible for cash sent through the mail.)

**NEW MEMBERS:** New members must complete the KTSA's orientation session. Contact Jim Bartlett at 250-374-6651 or email [jrbartlett@shaw.ca](mailto:jrbartlett@shaw.ca) with your contact information to make arrangements.

Please complete this application and bring it along with your membership and orientation fees in **cash** to your orientation session. The club only accepts **cash payments** from new members. (The orientation fee is not charged per person for family memberships.)

Please bring appropriate ear and eye protection to the orientation session. Also, review and be prepared to discuss the KTSA Range Rules (see [ktsa.ca](http://ktsa.ca)). You will receive your membership card(s) and an outdoor range key upon completion of the orientation and payment of your fees.

**New members** who join after September 1st and before October 31 will pay 50% of the current annual rate for the remainder of the year, plus the \$10 orientation fee.

After November 1<sup>st</sup>, new members who wish to join for the remainder of the current calendar year (at 50% of the annual rate plus the \$10 orientation fee), must at the same time join and pay for the following year. After November 1<sup>st</sup>, new members may choose to complete orientation and join for the following membership year only.
